3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **driver mechanic**, for which the qualification **AU.04.Exploitation of road transport means** has been specified, certifies that the holder is able to:

- select means of road transport in accordance with the transport service,
- perform work related to the exploitation of road transport means,
- use technical and operational documentation of road transport means,
- perform activities related to the maintenance and repair of road transport means,
- assess technical condition and quality of the repair of road transport means,
- prepare documents related to the transport and service of road transport means,
- estimate and calculate road transport costs,

– drive and operate motor vehicles in accordance with traffic regulations and regulations concerning road transport, using maps and subsidiary equipment used in road transport means, and additionally, within the scope of the professional tasks performed:

- observe the rules of occupational health and safety, apply fire and environmental protection regulations as well as requirements of ergonomics,
- provide first aid to the injured in accidents at work and in health and life-threatening situations,
- apply the provisions of the labour law, legal regulations concerning personal data protection, copyrights law and legal provisions concerning business activity,
- communicate in a foreign language in the performance of professional tasks as well as use foreign-language sources of information.

The holder of the certificate has obtained at least a basic vocational education and passed an examination for the qualification specified for the occupation of driver mechanic: **AU.04. Exploitation of road transport means**. This qualification can be obtained by pursuing one of the following educational paths.
