3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **technician in binding processes**, for which the qualifications: **AU.16. Performing bookbinding processes** and **AU.43. Planning and supervising polygraphic production** have been specified, certifies that the holder is able to:

- select methods and techniques for making bookbinding products,
 - prepare materials for making bookbinding products,
 - prepare and operate machines for making bookbinding products,
 - control bookbinding processes and assess the quality of bookbinding products,
 - prepare bookbinding products for shipment,
 - develop technology to manufacture a printing product,
 - calculate material requirements and costs of manufacturing printing products,
 - monitor and evaluate materials, semi-finished and finished printing products,
 - use control and measuring instruments and equipment,
 - implement corrective actions based on the analysis of printing processes,
 - use technical and technological documentation during printing production,
 - distinguish between printing processes,
 - use computer support for planning and supervising polygraphic production,
- and, in addition, within the scope of professional tasks performed:
- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
 - provide first aid to the injured in accidents at work and in life or health-threatening situations,
 - apply the provisions concerning business operation, labour law and personal data protection law,
 - use a foreign language and use foreign-language sources of information,
 - organise work of a small team.

Performing bookbinding processes and AU.43. Planning and supervising polygraphic production . These qualifications can be obtained by pursuing one of the following educational paths.
