## 3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **inland fishery technician**, for which the qualifications: **RL.02. Fishing in aquaculture** and **RL.15. Organising fishing work in aquaculture** have been specified, certifies that the holder is able to:

- perform works related to fish and crayfish breeding in ponds and pond maintenance,
- perform reproduction, raise stocking material and stock inland waters with fish,
- store, prepare and use feeds for feeding freshwater fish and crayfish,
- fish and harvest fish and crayfish with various methods and prepare fish and crayfish for sale,
- perform fisherman works in accordance with the law and keep job documentation,
- make selected fishing tools and repair their damage,
- distinguish and operate the equipment, tools, machinery and devices used in aquaculture,
- choose appropriate technology and plan fishery production on the basis of economic provisions and available equipment,
- execute projects and calculate the costs of construction of fishing net tools,
- perform activities related to combating fish diseases and treating fish under the supervision of a veterinarian,
- carry out fish and crayfish breeding development,
- perform the activities of securing raw materials and primary processing of fish and crayfish,
- perform work using a computer and office equipment,
- drive and operate a farm tractor,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information,
- organise work of a small team.

The holder of the certificate has obtained at least a secondary education and passed examinations for the qualifications specified for the occupation of inland fishery technician: <b>RL.02. Fishing in aquaculture</b> and <b>RL.15. Organising fishing work in aquaculture</b> . These qualifications can be obtained by pursuing one of the following educational paths.
