3. PROFILE OF SKILLS AND COMPETENCES
<p>The vocational diploma for the occupation of maritime navigation technician, for which the qualification AU.41. Watchkeeping at sea and in port has been specified, certifies that the holder is able to:</p> <ul style="list-style-type: none"> - plan and conduct safe navigation of a vessel in specific natural and weather conditions with the use of valid maps and navigational publications and available forecasts and warnings, - operate and use the ship navigation equipment, interpret its indications, detect malfunctions and take corrective actions, - communicate to provide safety and to operate, - keep watch at sea and in port and perform duties in emergency situations, - classify cargo and its packaging, determine cargo quantity, supervise its handling and fastening and monitor transportation conditions, calculate and control the stability of the vessel, - operate load-bearing, ventilation of cargo spaces and bilge systems, and on-board, handling, emergency, fire protection and rescue equipment, as well as assess their technical condition, - observe applicable navigation rules and keep documentation required thereunder and operation documents, supervise repair and maintenance works in the deck department, <p>and in addition, within the scope of professional tasks performed:</p> <ul style="list-style-type: none"> - observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics, - provide first aid to the injured in accidents at work and in life or health-threatening situations, - apply the provisions concerning business operation, labour law and personal data protection law, - use a foreign language and use foreign-language sources of information, - organise work of a small team.
