## 3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **marine fishery technician**, for which the qualification **RL.12. Watchkeeping at sea and in port on a fishing vessel** has been specified, certifies that the holder is able to:

- plan and conduct safe navigation of a vessel in specific natural and weather conditions with the use of valid maps and navigational publications and available forecasts and warnings,
- operate the navigational and fishing equipment of a vessel and interpret its indications,
- communicate to provide safety and to operate,
- keep watch at sea and in port and perform duties in emergency situations,
- operate on-board, fishing and handling equipment and load-bearing, ventilation of cargo spaces and bilge systems,
- observe applicable regulations and keep documentation required under such regulations,
- fish for marine organisms, perform their pre-treatment and transportation,
- operate ship power plants, auxiliary mechanisms of ship power plants, electrical equipment and automation systems on a fishing vessel,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information,
- organise work of a small team.
