<p>The vocational diploma for the occupation of avionics technician, for which the qualification EE.12. Performance of technical inspections of aircrafts and base maintenance of avionics equipment has been specified, certifies that the holder is able to:</p> <ul style="list-style-type: none"> – read and prepare logic, schematic, block and assembly diagrams of systems and electrical systems and avionics equipment of aircraft, – perform measurements of parameters and tuning of avionics equipment, components of the equipment and electrical systems during technical inspections of aircraft, – install and repair avionics and electrical equipment of the aircraft in accordance with the technical and operational documentation, – perform technical inspections, checks and maintenance of aircraft in accordance with the provisions of the aviation law, – prepare documentation and archive data concerning the repair and operation of aircraft, – use the laws of electrical engineering to calculate electrical and electronic circuits, – use computer systems supporting the aircraft operation, <p>and, in addition, within the scope of professional tasks performed:</p> <ul style="list-style-type: none"> – observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics, – provide first aid to the injured in accidents at work and in life or health-threatening situations, – apply the provisions concerning business operation, labour law and personal data protection law, – use a foreign language and use foreign-language sources of information, – organise work of a small team.
