3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **hearing aids orthotist**, for which the qualification: **MS.16. Provision of medical services in the field of hearing aids** has been specified, certifies that the holder is able to:

- distinguish terminology related to physiological and pathological functioning of the hearing organ,
- perform hearing tests for adults and children,
- organise the work station and prepare medical documentation,
- describe the design and classify hearing aids,
- select and adjust hearing aids for adults and children,
- perform measurements of hearing aids and perform their repairs,
- take ear cast (impression),
- make ear inserts and hearing aid covers,
- take a history of a poorly hearing patient,
- plan and provide audioprosthetic care for a poorly hearing patient,
- instruct the patient on the use of a hearing aid and hearing support devices,
- use electro-acoustic transducers,
- use a sign language,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information,
- organise work of a small team.
