3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **dental technician**, for which the qualification **MS.15. Making and repairing of medical devices in the field of dental prosthetics, orthodontics and facial epitheses** has been specified, certifies that the holder is able to:

- explain the anatomic structure of the facial skeleton,
- characterise teeth based on the anatomical description, use systems for marking teeth, classify missing teeth,
- prepare plaster diagnostics models and working upper and lower jaws,
- design prosthetic structures, analyse and assess the quality of designs made,
- make dentures, orthodontic devices and facial epitheses in accordance with the clinical design,
- apply materials used in the production and repair of medical devices,
- characterise the principles of operation and application of orthodontic devices,
- operate equipment used in the production of medical devices,
- use modern technologies applied in the work of a dentistry technician,
- use a sign language,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information,
- organise work of a small team.
