The vocational diploma for the occupation of **child care worker**, for which the qualifications: **MS.11. Providing care services and services supporting child development** has been specified, certifies that the holder is able to:

- observe safety principles related to biologically contaminated materials and principles of aseptics and antiseptic,
- meet biological, psychological and social needs of a healthy, sick and disabled child,
- conduct preventive activities and develop and consolidate hygiene and health-related habits in children,
- teach a child how to be self-reliant and shape positive personality traits,
- evaluate and stimulate physical and psychomotor development of a child,
- develop child's interests in artistic and technical creativity,
- conduct music and movement classes taking into account children's age, level of development and capabilities,
- work in a team within the scope of child care, education and development,
- work in a team within the scope of care, treatment and rehabilitation of a sick and disabled child,
- recognise symptoms of childhood diseases and differentiate types of disability,
- follow the law in cases of suspected child abuse,
- use a sign language,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information,
- organise work of a small team.
