The vocational diploma for the occupation of **agribusiness technician**, for which the qualifications: **RL.03. Running agricultural production** and **RL.07. Organising and running an agribusiness company** have been specified, certifies that the holder is able to:

- match plant species and varieties as well as the species, breeds and productive types of animals to farm conditions,
  - select, operate and maintain machinery, equipment and means of transport for an agricultural farm,
  - plan and carry out work in conventional and organic agriculture in accordance with cross-compliance and economic calculation rules,
  - store, prepare for sale and conduct direct sale of agricultural products,
  - plan, organise and run an agribusiness company taking into account financial and staff requirements,
  - organise and conduct food processing in accordance with the provisions for ensuring quality and health safety,
  - keep full and simplified accounting records of an agribusiness company, calculate costs, calculate salaries and government and public agency charges,
  - use computer programmes supporting the performance of professional tasks,
- and, in addition, within the scope of professional tasks performed:
- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
  - provide first aid to the injured in accidents at work and in life or health-threatening situations,
  - apply the provisions concerning business operation, labour law and personal data protection law,
  - use a foreign language and use foreign-language sources of information,
  - organise work of a small team.
