## 3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **assistant to movie/television production manager**, for which the qualification: **ST.09. Preparation and organisation of movie/television production** has been specified, certifies that the holder is able to:

- plan and draw up documentation concerning the preparation and execution of movie/television production,
- select members of the executive staff and cast,
- make estimates of the planned production and draw up agreements with participating entities and demands for services, equipment and materials,
- monitor costs of the production and compliance of its execution with the schedule,
- organise works connected with the movie set and its liquidation and protect the property rented in accordance with the procedures,
- select editing sets, postsynchronisation materials and organise the work of actors,
- organise works in the field of technical inspections and acceptance of movie/television production and duplication of finished works,
- perform activities related to the dissolution of a team, settlement of the production and archiving of documentation,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information,
- organise work of a small team.
