Warehouse operation has been specified, certifies that the holder is able to:

- organise warehouse processes,
- adapt fittings and equipment to the performed warehousing processes and the stock stored,
- store and secure stock and control its condition in the warehousing process,
- prepare and perform quality and quantity acceptance and inventory-taking in the warehouse,
- pack and mark goods according to valid rules and a client's recommendation,
- plan cargo handling activities,
- pick materials for production according to the description and structure of the product and production system,
- manage wastes and packages in accordance with valid principles and laws,
- provide client and contractor service in the distribution channel,
- apply IT systems used in warehouse management,
- determine costs of warehousing services,
- prepare warehouse documentation in a Polish and foreign language,

and additionally, within the scope of the professional tasks performed:

- observe occupational health and safety regulations, fire safety and environmental protection regulations and requirements of ergonomics;
- provide first aid to the injured in accidents at work and in health and life-threatening situations,
- apply legal provisions relating to the conduct of business activity, labour law, personal data protection and professional secret,
