3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **farmer**, for which the qualification **RL.03.Running agricultural production** has been specified, certifies that the holder is able to:

- match plants to climate and soil and economic conditions of the region and farm,
- plan and perform works connected with the soil cultivation, sowing, planting, fertilization, care, protection and harvesting of plants in conventional and organic agriculture, while observing the principles of mutual compatibility and economic calculation,
- match species, breeds and productive types of animals to farm conditions,
- plan and perform works connected with nutrition, reproduction, care and use of farm animals in accordance with the principles of cross-compliance in a conventional and organic farm,
- select, prepare for work, operate and maintain tools, machines, equipment, vehicles and means of transport used in agricultural production,
- operate renewable energy systems, water supply and drainage equipment on the farm,
- store, prepare for sale and conduct direct sale of agricultural products,
- use computer programmes supporting the performance of professional tasks,
- drive and operate a farm tractor,

and additionally, within the scope of the professional tasks performed:

- observe the rules of occupational health and safety, apply fire and environmental protection regulations as well as requirements of ergonomics,
- provide first aid to the injured in accidents at work and in health and life-threatening situations,
- apply the provisions of the labour law, legal regulations concerning personal data protection, copyrights law and legal provisions concerning business activity,
- communicate in a foreign language in the performance of professional tasks as well as use foreign-language sources of information.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

The holder of the certificate has obtained at least a basic vocational education and passed an examination for the qualification specified for the occupation of farmer: **RL.03. Running agricultural production**. This qualification can be obtained by pursuing one of the following educational paths.
