3. PROFILE OF SKILLS AND COMPETENCES

The vocational diploma for the occupation of **fitter of building isolations**, for which the qualification **BD.07. Making building isolations** has been specified, certifies that the holder is able to:

- distinguish designs of civil structures and types of waterproof, thermal, acoustic and anti-vibration insulations and identify types of corrosion,
- use documentation necessary to make building insulations and prepare working drafts,
- prepare take-off and quantity survey of insulation works and calculate the costs of making building insulations and account for them,
- select methods, materials, tools and equipment to isolate building elements,
- perform ancillary construction works and prepare ground for building isolations,
- make waterproof, thermal and acoustic isolations of space dividing elements, anti-vibration isolation of civil structure elements, machinery, equipment and building systems and anti-corrosion and chemical-resistant coatings of building elements and assess their quality,
- assess the technical condition of isolations and perform works related to the repair of waterproof, thermal, acoustic and anti-vibration isolations,

and, in addition, within the scope of professional tasks performed:

- observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics,
- provide first aid to the injured in accidents at work and in life or health-threatening situations,
- apply the provisions concerning business operation, labour law and personal data protection law,
- use a foreign language and use foreign-language sources of information.
