The vocational diploma for the occupation of fitter of finishing elements and contractor for finishing works in construction industry , for which the qualification: BD.04. Performing installation, cladding and finishing works has been specified, certifies that the holder is able to: <ul style="list-style-type: none"> - install partition walls and wall cladding on the properly prepared base, in accordance with the documentation, - make isolations used in drywall systems and flooring and cladding works, - repair partition walls, suspended ceilings and roof sheathing in the drywall system, - make paint and wallcovering coatings including the preparation of the base, - repair damaged paint and wallcovering coatings and renovate them, - prepare the base and make a prime for floor finish and cladding with the use of design documentation, - make and repair floor finish and cladding in accordance with the design documentation and assess the quality of works completed, - assess the quality of works in the drywall system, painting and wallpaper and flooring and cladding works and calculate their costs, and, in addition, within the scope of professional tasks performed: <ul style="list-style-type: none"> - observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics, - provide first aid to the injured in accidents at work and in life or health-threatening situations, - apply the provisions concerning business operation, labour law and personal data protection law, - use a foreign language and use foreign-language sources of information.
