Performing chimney sweeping works has been specified, certifies that the holder is able to:</p> <ul style="list-style-type: none"> - read from the technical and technological documentation information to perform professional tasks and prepare simple drafts and drawings within the scope of chimney sweeping works, - select and operate tools, equipment and measuring instruments to perform chimney sweeping works, - select materials for the performance of chimney sweeping works, - observe legal regulations concerning chimney sweeping works performed, - perform acceptance procedures of chimney ducts in newly constructed civil structures in accordance with the design, standards and technical conditions of the execution and acceptance of works, - perform periodic inspections of technical condition and clear, insulate and clean chimney and ventilation ducts and heating equipment, - perform basic measurements during the execution of chimney sweeping works, - prepare chimney-sweep opinions and documentation from the inspection of chimney ducts and connections of heating and ventilation equipment, - prepare take-off, quantity survey and calculation of chimney sweeping works, - evaluate the accuracy and quality of chimney sweeping works completed and remove any possible defects, <p>and, in addition, within the scope of professional tasks performed:</p> <ul style="list-style-type: none"> - observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics, - provide first aid to the injured in accidents at work and in life or health-threatening situations, - apply the provisions concerning business operation, labour law and personal data protection law, - use a foreign language and use foreign-language sources of information.
