Making and repairing goldsmith's and jeweller's products has been specified, certifies that the holder is able to:</p> <ul style="list-style-type: none"> - plan the execution of professional tasks with the use of technical and technological documentation and prepare drafts of goldsmith's and jeweller's products, - select and use control and measurement tools, equipment and instruments during the performance of goldsmith's and jeweller's works, - select and account for precious metals and materials and conduct rational management of precious metal waste, - make precious metal alloys in accordance with the hallmarking law, - perform processing of precious metals and their alloys and make temporary and permanent fastening of goldsmith's and jeweller's components and products, - make holders and settings of jewellery stones, - assess the condition of goldsmith's and jeweller's products, select technologies and repair and modify the products, - evaluate the quality of goldsmith's and jeweller's works performed and remove any possible defects, - maintain tools, instruments, equipment and machinery used in goldsmith's and jeweller's works, - observe the principles of labour culture and professional ethics, <p>and, in addition, within the scope of professional tasks performed:</p> <ul style="list-style-type: none"> - observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics, - provide first aid to the injured in accidents at work and in life or health-threatening situations, - apply the provisions concerning business operation, labour law and personal data protection law, - use a foreign language and use foreign-language sources of information.
