Making basket and wattle products has been specified, certifies that the holder is able to:</p> <ul style="list-style-type: none"> - identify raw materials and materials used in basket and wattle production, - perform works related to the processing and refining of materials used in basket and wattle works, - classify basket and wattle products, - determine the quantity of materials necessary for the manufacture of basket and wattle products, - select materials and technology for the manufacture of basket and wattle products, - prepare and make construction components of basket and wattle products, - perform technological operations related to the assembly of components, strengthening of the structure, completion of products, - use techniques for finishing and refining basket and wattle products, - perform repair and renovation of basket and wattle products, - assess the quality of works performed and finished products, - select methods of packaging, storage and transportation of basket and wattle products, - use product technical and technological documentation, <p>and, in addition, within the scope of professional tasks performed:</p> <ul style="list-style-type: none"> - observe occupational health and safety, fire and environmental protection regulations and requirements of ergonomics, - provide first aid to the injured in accidents at work and in life or health-threatening situations, - apply the provisions concerning business operation, labour law and personal data protection law, - use a foreign language and use foreign-language sources of information.
