The vocational diploma for the occupation of **craftsman of textile products**, for which the qualification **AU.18. Manufacture, maintenance and renovation of handicraft textile products** has been specified, certifies that the holder is able to:

- plan the activities related to repair, renovation and maintenance of decorative textile products,
 - manufacture and finish handicraft textile products,
 - renovate and maintain decorative textile products,
 - develop drawings of weaving and knitting strands,
 - prepare designs of handicraft textile products,
 - select raw materials, semi-products to manufacture handicraft textile products,
 - select techniques of manufacturing handicraft textile products,
 - prepare machinery, tools and auxiliary items for production of handicraft textile products,
 - assess the quality of handicraft textile products,
 - assess the quality of services performed,
 - prepare cost calculations of production of handicraft textile products,
 - prepare cost calculations of services related to maintenance and renovation of decorative textile products,
- and additionally, within the scope of the professional tasks performed:
- observe the rules of occupational health and safety and ergonomics and apply fire and environmental protection regulations,
 - provide first aid to the injured in accidents at work and in health-threatening situations,
 - apply legal provisions relating to the conduct of business activity, labour law and personal data protection law,
 - use a foreign language and use foreign-language sources of information.
