 - repair electrical and electronic systems of automotive vehicles,
 - prepare documentation for servicing and repair of electrical and electronic systems of automotive vehicles,
 - perform work in scope of mechanical installation of electrical and electronic elements and devices,
 - prepare technical drawings,
- and additionally, within the scope of the professional tasks performed:
- drive and operate an automotive vehicle to the extent necessary to obtain a driving license of B category,
 - observe occupational health and safety regulations, fire safety and environmental protection regulations and requirements of ergonomics;
 - provide first aid to the injured in accidents at work and in health and life-threatening situations,
 - apply legal provisions relating to the conduct of business activity, labour law and personal data protection law,
 - use a foreign language and use foreign-language sources of information.
